Abraham “Avi” Reichman has more than 17 years’ experience as a CPA and over 13 years specializing in the area of forensic accounting. Avi has provided forensic accounting services in numerous litigation matters, including marital dissolution matters and civil litigation disputes. He has testified as an expert witness in over 50 matters throughout the State of California and has served as a court appointed expert. He has also been a guest speaker and lecturer for various professional associations.

### **EDUCATION, PROFESSIONAL LICENSES, MEMBERSHIPS AND CREDENTIALS**

Avi received a Bachelor of Science in Accounting summa cum laude, in 2003. That same year, he sat and passed the CPA Exam, scoring in excess of 90% on all 4 parts of the exam. He has been a licensed CPA since 2005.

Avi is a member in good standing of both the American Institute of Certified Public Accountants (AICPA) and the California Society of CPAs (CalCPA). In 2010, he earned the AICPA’s “CFF” (Certified in Financial Forensics) credential and in 2011, he earned the AICPA’s “ABV” (Accredited in Business Valuation) credential.

After passing the CPA exam, Avi joined Deloitte & Touche LLP (“Deloitte”) in Los Angeles, CA. He started in their Audit and Assurance department, but quickly rose through the ranks and was promoted to manager in 2007. While in this role, he held the distinction of being one of Deloitte’s youngest managers in the country. Avi audited some of the office’s largest clients and assisted with some of the firm’s most prestigious engagements, which included providing assurance services for stock option backdating investigations and private equity leveraged buyouts. Avi also served as a facilitator for the firm’s national training-teaching staff at various levels across the country.

In 2009, Avi was invited to join David Frankel Accountancy Corporation, also in Los

Angeles, CA. He was a manager and quickly helped build the client roster and secure talent. This was a small boutique firm that specialized in the niche area of forensic accounting, with a focus in providing litigation support in both family and civil matters, in addition to providing tax planning and compliance services.
